greetings from our board of directors

On behalf of the Zebra Child Protection Centre Board of Directors, CEO, staff and volunteers we are pleased to present our 2019 Annual Report.

The Zebra Child Protection Centre is our community's response to child abuse. In 2019, 2,362 children, youth and their families were supported by the Zebra Centre, which represents a 12.6 per cent increase over the number of children supported in 2018. Every child was able to tell their story in a safe space where they were heard, believed and supported. The Zebra Centre provides resources and guidance throughout the entire disclosure, investigative, judicial and healing process.

As a Child Advocacy Centre (CAC) we are committed to our role of keeping children and youth in our community safe. 2019 was a year of significant growth for the Zebra Centre. Through our work with CACs provincially and nationally we have created a community that is much larger than just the Edmonton area. By working together we are creating safer communities and providing hope to children and youth who have experienced abuse.

Each year our numbers keep growing, but we don't believe this is necessarily attributed to an increase in child abuse within our community, rather it signifies that our community members are recognizing the

ethical and legal obligation to report abuse. We are grateful to be a part of a community that has shown they will step up for the children and youth who need our support.

Children are naturally resilient - given the right tools, surrounded by a community that cares, they can move beyond the hurt, knowing that they have told their story and are believed. With the support of our community we are able to ensure that each child receives the customized resources they need as they move through their healing journey.

The Zebra Child Protection Centre is the result of a strong community response working to end child abuse through collaboration of services and resources. Every child has a story and at the Zebra Centre, we are here to be a voice for children and youth who haven't vet found theirs.

child advocacy centres of Canada

Canada is a geographically large country with an ethnically diverse population that lives in large crowded cities, mid-sized towns and remote communities. A variety of Child Advocacy Centre (CACs) & Child and Youth Advocacy Centre (CYACs) models exist in Canada to meet the needs of different communities. The National Network aims to be a National voice for Canadian CACs and CYACs in responding to child abuse.

Each year all CACs and CYACs across Canada meet for two days to network, learn and build working relationships amongst each other. From the greater National Network, provincial networks have been created to further unify and strengthen the provincial voice of those working to advocate for children and youth who have experienced abuse. The National Network is a relentless champion for children and youth through its support of all Canadian CACs and CYACs from coast to coast to coast. Its focus is raising awareness, increasing capacity and advancing sustainability on the national stage.

"The provincial wide voice allows us to have consistency and a further reach in our messaging. 
child advocacy centres of Alberta

The Child Advocacy Centres in Alberta have a strong history of supporting one another through information and resource sharing. In 2019, these relationships were formalized through the development of the Provincial CAC Network.

The Provincial CAC Network meets guarterly, which has created a space for the provincial CACs to come together to share information, best practices and make decisions moving forward that impact the work they do.

The Network's goal is to create a common provincial voice regarding CAC work and positively impact the outcomes for Albertans served by the CACs. The network strives to create consistency and equity of service throughout the province. Representatives from the Ministries supporting the work of CACs also attend the Network meetings. This strengthens the partnership between government and CACs to ensure there is open dialogue around issues that are impacting the work of CACs.

A Provincial CAC Communications Committee has also been created as a result of the Network.





Representatives from each CAC work collaboratively to create consistent provincial messaging and content. The committee has worked together to publish joint news releases and create consistent educational information - showing unity across the province and strengthening the voice of children and youth throughout Alberta. The committee continues to work towards greater unity and reaching all Albertans through their communication efforts.




AGE AT THE TIME OF REPORTING







We are there every step of the way. Children and you find justice and healing through our Court Support Program. Our goal is to ensure children and youth know they are believed and get the opportunity to speak their truth, no matter the court outcome. The Zebra Centre extends our services throughout the entire court process by working with Alberta Crown Prosecution Services. Our support includes providing updates to families on court proceedings, preparing children for their day in court and addressing any feathey may have. An experience that is similar to the Zebra Centre has been created within the Court Hous by providing our children, youth and their families with a safe, secure place to wait at court and by accompanying them on the stand as they testify.

Sometimes the best support comes on four legs. Wre and Fletcher are the Very Important Paws (VIP) team at the Zebra Child Protection Centre. With no words spoken they provide our children and youth with the strength to speak their truth, whether that is at the Zebra Centre or in the Edmonton Law Courts. Their ability to relieve stress and anxiety is astounding and is just what each child who is supported by Wren or Fletcher needs to begin their healing journey.

new programs

EXPANDED CULTURAL AND DIVERSITY PROGRAM

The Zebra Child Protection Centre believes in creating a space for all children to feel safe, believed, comfortable, supported and where kids always come first. Based on that belief we felt that we needed to increase the diversity of both our physical space and programming to ensure that our supports and best practices continue to serve a diverse group of children, youth and their families who walk through our doors.

Our "Caregiver's Guide" is currently translated into eight different languages, making it accessible to a variety of non-English speaking families. We work with our partners to provide language interpretation services to children who are more comfortable speaking in their native language during forensic interviews and court proceedings. We recognize that culture not only incorporates ethnicity, but also encompasses sexual orientation, gender identity, ability levels, immigration status, socioeconomic status, religion and age.

We expanded our community partnerships to ensure that we are continuously evolving to meet the needs of every child – acknowledging their cultural and diverse qualities. The Centre is now able to provide customized information and referrals to integral organizations within our community to meet their needs.

Our expanded partnership with the Multicultural Health Brokers (MCHB) and Bent Arrow Traditional Healing Society (Bent Arrow) ensures all our staff, volunteers and partners receive appropriate training; knowledge and information on culturally relevant practices to better serve our clients. We will continue to invest in expanding our training for staff. volunteers and partners.

Additionally, we updated our physical spaces with art, toys, books, quilts and other items to help reflect the diversity of our children and youth who visit the centre. We want them to be able to see themselves reflected within our space.

We have been working with three local schools -Westmount Junior High, Amiskwaciy Academy and Prince Charles School to have their students create new art for our Centre. The art is a depiction of how they see themselves and the community in which they live. These strong, powerful and beautiful works of art are as diverse as our clients and will be proudly displayed throughout our Centre. Offering visual support, inspiration and showcasing our commitment to each and every child. Children supporting children.

In the fall of 2019, in partnership with Bent Arrow - we invited Elder Tom Snow into our Centre to perform a Smudging Ceremony. Our partners, staff, volunteers and our Board of Directors were able to participate and be part of a spiritual ceremony that signified our move towards a more culturally inclusive practice within our walls.

The guiding principle of the City of Edmonton's Strategic Plan for 2019 – 2028 states "We create as a community to connect people to what matters to them. We care about the impact of our actions on our social, economic, cultural, spiritual and environmental systems. We serve those here today and those who come after us." This guiding statement not only speaks to the importance of recognizing and celebrating the diversity of our community, but also to what we are striving to do here at the Zebra Centre - ensuring every child has a voice and the necessary supports needed throughout their healing journey.


